- ◆ Applicant household must provide front page of last year's tax return.
- ◆ 2 references for student from teacher, clergy, neighbor, family friend
Please include: name, phone number, address
- ◆ Recipients must be residents of Missouri.

How are recipients selected? Presser Performing Arts Center will select recipients based on the criteria listed and the limits of the finances available for the year.

- ◆ Applicants should have financial need beyond what they and their family can provide.
- ◆ Guardian section of application is very important. Please attempt to make a compelling case for support.
- ◆ Student section of application is very important. Please attempt to make a case that is compelling for support.
- ◆ If a student is repeatedly late or absent, they may be placed on probation from receiving a scholarship and will be required to pay for program.
- ◆ Effort will be made to provide assistance to individuals attending each of the arts education programs based on merit and need.
- ◆ Effort will be made to provide assistance to individuals from a variety of backgrounds and talents.
